PASSED

SB 224 Extension of civil statute of limitations for adult and minor victims of sexual assault

Sponsor: Wil Schroder http://www.lrc.ky.gov/recorddocuments/bill/17RS/SB224/bill.pdf Passed Senate 36-0; Passed House 97-0; Signed by Governor 3.27.17

- 1. Adults: Extended from 1 to 5 years
 - a. Covers specific sex crimes, listed in statute
 - b. Added 5 years upon conviction of defendant
- 2. Minors: Extended from 5 to 10 years
 - a. Added 10 years upon conviction of defendant

(HB 407 to extend childhood sexual abuse or assault civil statute of limitations - Sponsors: Chad McCoy, Addia Wuchner, Walker Thomas, C. Wesley Morgan, was added to SB224)

SB 86 removed mandatory spousal abuse reporting and added mandatory information for victims of dating violence and abuse and domestic violence and abuse

Now requires that certain professionals (listed in the statute) who have *reasonable cause to believe that* a victim with whom he or she has had a professional interaction has experienced domestic violence and abuse or dating violence and abuse, SHALL provide them with educational materials related to domestic violence and abuse or dating violence and abuse including information about how he or she may access regional domestic violence programs or rape crisis center programs and information about how to access protective orders.

Requires DV service providers, as designated by the Cabinet, to make *educational materials available on* web or in print form for professionals to provide to possible victims.

A professional shall report to a law enforcement officer his or her belief that the **death** of a victim with whom he or she has had a professional interaction is related to domestic violence and abuse or dating violence and abuse.

HB 309 Added protections for tenants under leases and rental agreements

- 1. Covers persons ("*protected tenant*": residential rental or leased housing tenant, applicant for tenancy, or tenant with minor household member) who have EPO/DVO, TIPO/IPO, or pretrial release no contact order.
- 2. Landlord cannot terminate, fail to renew, refuse to enter into, or otherwise retaliate in renting or leasing due to protection order.
 - a. Protected tenant may have a defense in an action for possession of property by landlord
- 3. Tenant may install a new lock if, they inform landlord of intention, pay for it on own, and shall give new key to landlord upon request.
- 4. May terminate current lease if valid protective order obtained while living at that property if:a. Provide 30 days written notice and a copy of the protective order to the landlord.
- 5. After obtaining a protective order, may terminate lease at a subsequent property if:
 - a. Provide 30 days written notice, copy of protective order, and demonstrate safety concern to landlord that arises after execution of the lease
- 6. Upon termination, tenant liable for prorated rent and not to receive a negative credit entry nor negative character reference.
- 7. Perpetrator, whether a party to the lease or not, shall be civilly liable for all economic losses incurred by landlord for early lease termination, costs to repair premises, etc.
- 8. Landlord may take action against perpetrator if they are a tenant on the lease by terminating their lease, evicting them, and action for damages.

HB 38 prohibit sex offender registrants from being on publicly owned playground without advance written permission

- 1. Prominent display of National Human Trafficking Hotline number
 - a. At public schools
 - b. At Rest stops in English and Spanish, using gender-neutral language
- 2. Added list to definition for serious physical injury for children 12 years or less at time of injury

SB 236 Background checks from child abuse and neglect records

- 1. Parents and legal guardians may request when employing a person for childcare
- 2. Private schools may request child abuse check on staff, volunteers, etc
- 3. Public schools shall require background checks, including child abuse
- 4. Youth camps must perform background checks including child abuse and neglect records
