### **FUNDAMENTAL RESPONSIBILITIES:**

The SANE/SART Coordinator will operate with these basic tenets in mind: SANE programs exist to:

Reduce the traumatic nature of the forensic examination and barriers to seeking help for victims of rape and sexual assault;

Promote increased prosecution through help for victims of rape and sexual assault

Promote increased prosecution through improved collection of evidence and coordination of professionals

Improve the ability of the healthcare system in Kentucky to respond to sexual assault cases;

Improve the coordination of forensic medical, victim advocacy and criminal justice related services on behalf of the victims of sexual offenses.
