#### Who We Are

The Kentucky Association of Sexual Assault Programs (KASAP) is the coalition of Kentucky's 13 regional rape crisis centers which offer free, specialized services to survivors of rape and other kinds of sexual violence. These centers help survivors through the entire healing process, from crisis to long-term recovery.

Services include: 24/7 helpline support; medical, legal, and personal advocacy; counseling; and specialized therapy. Programs also provide community outreach and awareness, prevention education, and professional training.

# Survivor Healing and Support

The Impact of Counseling, Advocacy, and Trauma-Informed Response

### **Healing Happens Here**

When survivors are believed, supported, and connected to specialized care, healing becomes possible. Kentucky's communities become safer and stronger.

The **Healing Voices Project** is KASAP's statewide evaluation tool that gathers feedback from survivors. It helps us understand what survivors experience in hospitals, courtrooms, and during counseling.

Data from the Healing Voices Project shows that survivors report:

- Improvements in trauma symptoms
- Increased feelings of empowerment
- High satisfaction with the services they received
- 81% of survivors reported supportive, respectful interactions with both medical and legal personnel
- With an advocate present, victim-blaming was extremely rare (1–3%)

# **KASAP Success Stories**



### **Training That Transforms Care**

When Kentucky passed **HB219**, hospitals wanted guidance. In response, KASAP led a statewide coalition to create trauma-informed training videos that are now part of the **Kentucky Hospital Association's official curriculum**. This ensures every emergency department has the tools to respond compassionately and consistently to survivors.

### **Comfort When It Matters Most**

Thanks to a generous \$15,662 grant from the Honorable Order of Kentucky Colonels' Good Works program, KASAP distributed Medical Advocacy Care Bags filled with clothing and essential items for survivors leaving the hospital after an exam. A simple bag can make an enormous difference in dignity and comfort.

"These contributions offer more than material aid," said Dr. Amy Cappiccie, Interim Executive Director and Clinical Director at the Sexual Violence Resource Center of the Bluegrass. They also "help restore agency, reduce retraumatization, and lay the groundwork for long-term healing."



### **Empowering Advocates Across Kentucky**

In 2025, KASAP launched a **new 40-hour training program for victim advocates**, combining online and in-person sessions to build the skills, knowledge, and confidence needed to provide trauma-informed, survivor-centered care. Covering topics from crisis intervention to self-care, the training ensures advocates are prepared, supported, and ready to meet survivors with compassion.

### **Exploring Connections, Expanding Impact**

In May 2025, KASAP hosted the Access Healing Summit, a free one-day training in Bowling Green supported by the Access Healing Grant. The event brought together around 100 professionals from rape crisis centers, healthcare, and substance use prevention and response. It offered Continuing Education credits and a self-care component, sparking new approaches to understanding the **intersection of substance use and sexual violence**, strengthening collaboration, and improving support for survivors across the state.

# Preventing Violence **Before It Starts**

Teaching Prevention, Changing Futures

### **Why Prevention Matters**

Sexual violence continues to impact Kentucky families at alarming rates. CDC data shows that 39% of Kentucky women and 18% of men have experienced contact sexual violence in their lifetimes. A 2019 survey found that 12% of high school girls and 5% of boys experienced sexual violence in the past year.

Prevention education equips young people to recognize abuse, set boundaries, and speak up, creating safer schools and communities across the Commonwealth.

### A Student's Story

In early 2025, a middle school student in the Owensboro area recognized and reported sexual abuse by a teacher because of lessons she received at school from New Beginnings' trained prevention educators.

Her disclosure led to immediate intervention, showing how prevention can change the course of a child's life.

"Before I was scared to say anything and couldn't recognize violence or bullying, but now I have been able to see the signs and say something."

# Policy In Action

### **Building a Safer Kentucky**

KASAP plays a vital role in advancing survivor-centered legislation in Kentucky.

As the statewide coalition for all 13 regional rape crisis centers, we work year-round with lawmakers, state agencies, survivors, and community partners to strengthen protections, expand services, and support meaningful prevention.

From helping draft bills to offering expert testimony, KASAP ensures survivors' needs remain at the heart of Kentucky's legislative process.







### **KASAP's 2025 legislative wins**

HB 219

Secured mandatory SANE/SAFE training for EMS staff to improve survivor care in emergency settings.

HCR 20 Launched a statewide study to address gaps in SANE access positioning our centers to shape data-driven policy.

SB 73 Helped criminalize sextortion and introduce school-based awareness to protect youth.

HB 38 Strengthened protections by increasing penalties for repeat protective order violations involving force or threats.

SB 181 Expanded schools' ability to provide age-appropriate child sexual abuse prevention education.

In May, KASAP honored Representative Rebecca Raymer with the **Champion for Justice Award** at Med Center Health in Bowling Green. Nearly 40 advocates, nurses, members of law enforcement, and community leaders gathered to celebrate her work on HB219 and HCR20. Jenna Cassady, KASAP's Staff Attorney, and Melissa Whitley, Executive Director of Hope Harbor, shared remarks on the real-world impact of these policies, highlighting how policy and compassion together strengthen survivor care across Kentucky.


